**TO: All License Applicants RE: Background Checks for License Applicants**

The City of Princeton Police Department is required per the City of Princeton Ordinances and Wisconsin Statutes to do background checks on all alcohol license applicants. Please be advised of the following: This form asks if you have been convicted of certain offenses. It is your responsibility to fill this form out accurately. You must obtain the information concerning your arrest record and note it appropriately on the form, and upon completion of the application you will be stating that the answers to the questions are true and correct and asked to sign the application in the presence of a Notary Public. You are further advised that any license issued contract to Chapter 125 of Wisconsin Statutes shall be void and under penalty of state law, the applicant may be prosecuted for submitting false statements in connection with the application. Your license will have a recommendation of denial from the Police Department if it is found that the information is incorrect or if you have omitted information. Upon request, a copy of adopted guidelines specifying the approval policy, reasons for denial, non-renewal, or revoking the operator's license and how to appeal the denials to the Princeton City Council may be requested from the City Clerk. If you have any questions on what is required on your application, it is your responsibility to ask the City Clerk or contact the Police Chief of the Princeton Police Department prior to signing below.
